#### J Pro Classroom Learning Terms and conditions

## 1) Missed class function

- 1.1) Students who registered for classroom learning and in any circumstances are not able to attend or missed certain class date for the course, can book a time-slot provided by J Pro Business Training admin. Each time-slot booked is charged RM 30.00 per time-slot. This charges will be for the use of J Pro Business Training facility and services.
- 1.1.1) What is a time-slot. Time-slot are missed class video session which are provided by J Pro Business Training admin for students who want to review the missed class. Each time-slot is in the range of 3 hours to 5 hours. Payment for time-slots must be done earlier or on the day before attending the time-slot session.
- 1.2) Any booked time-slots by the student and physically did not attend the booked time-slot session, will be considered as 1 used time-slot. If the booked session has been prepaid and not attended, only RM 15.00 is transferable to the next time-slot booking. Time-slot timetable will be provided via class group WhatsApp or upon student request.
- 1.3) Location to view the missed class videos will be at J Pro Business Training center in Kemuning Utama, Shah Alam.
- 1.4) Missed class can be also viewed via online for a 24 hours range per time-slot session. Student will need to inform J Pro admin on whether they want to have a physical missed class session or online session. Online missed class session fees paid has no refund and non-transferable.

### 2) Timetable

- 2.1) Any changes made after the publication of the official course timetable for the said exam cycle, will be made available and announced accordingly using the communication method deployed by JPro Business Training. Replacement classes will be issued accordingly.
